Avoid prolonged or repeated breathing of vapour or mists. Avoid contact with skin, eyes and clothing. Make sure to wear personal protective equipment mentioned in this Safety Data Sheet. Keep containers tightly closed when not in use. Containers of this material may be hazardous even when empty.
