4. First-aid	measures

Degradability	Acetone undergoes slow photolysis in air (half-life time T1/2 = 80 h) and in water (T1/2 >43 h). 1-Chloro-4-(trifluoromethyl)benzene is not degraded by photolysis in water. According to an estimated Bioconcentration Factors (BCF) of 110 in fish and an estimated partition coefficient log Kow of 3.6 suggest that 1-Chloro-4-(trifluoromethyl)benzene has a potential for bioaccumulation in aquatic organisms is high (TOXNET). The Log Kow value <0.4 and bioconcentration factor (BCF) value <1 for isopropyl alcohol show no potential to bioaccumulate (IUCLID). Propylene glycol monomethyl ether has a Bioconcentration Factor (BCF) of 2.2 and a partition factor Log Kow of -0.49, indicating no potential for bioconcentration in aquatic organisms (TOXNET).						
Mobility in soil	Acetone evaporates very rapidly from dry soil surfaces. It is very soluble in water and it is expected to have very high mobility in soil with no adsorption to sediment. The Koc value of 1600 suggest that 1-Chloro-4-(trifluoromethyl)benzene is expected to have low mobility in soil (TOXNET). Isopropyl alcohol is soluble in water and will quickly evaporate into the air. There is no partition in the ground. Propylene glycol monomethyl ether is very soluble is water. Then, it is expected to have very high mobility in soil.
