4. First-aid measures

Inhalation	Move person to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen by trained personnel. If a problem develops or persists, seek medical attention.
Skin contact	Wash skin with warm water and mild soap. Remove contaminated clothing and wash before reuse. If a problem develops or persists, seek medical attention.

5. Fire-fighting measures

7. Handling and storage

Precautions for safe handling	Keep away from heat, sparks and open flame. Turn off all pilot lights, flames, stoves, heaters, electric motors, welding equipment and other sources of ignition. Use non-sparking and antistatic tools. Use only in well ventilated area. Do not breathe vapors. Avoid contact with skin, eyes and clothing. Wear eye protection, gloves and other protective clothing that are adapted to the task being performed and the risks involved. Keep containers tightly closed when not in use. Do not eat, do not drink and do not smoke during use. After use, wash hands with soap and water. Wash contaminated clothing before reuse.

Individual protection measures

Carcinogenicity	Contains material which can cause cancer. Contains trace amounts (>0.1%) of free formaldehyde (CAS no. 50-00-0) which is classified as carcinogenic to humans (IARC, Group 1). Titanium dioxide in dust form can cause cancer (through inhalation) based on animal data. Although IARC has classified titanium dioxide as possibly carcinogenic to humans (2B), their summary concludes: No significant exposure to titanium dioxide is thought to occur during the use of products in which titanium dioxide is bound to other materials, such as paint and caulk. Ethylbenzene is a proven carcinogen to animals and a possible carcinogen to humans. There is sufficient evidence for the carcinogenicity of alcoholic (Ethanol) beverages in humans (IARC).
